At least \$34,600 but less than \$35,500	10%
At least \$35,500 but less than \$36,400	5%

The exemption will take effect for assessment rolls with taxable status dates occurring on or after January 2, 2009, and will apply to the 2009-2010 school tax bills. The filing period for Persons with Disabilities and Limited Income Exemption is September 1ST through January 2nd.

2. <u>Senior Citizen Exemption</u>: Pursuant to the authority provided by Chapter 462 of the New York Real Property Tax Laws passed in 2003, amending §467 of the Real Property Tax Law, the Board of Education hereby adopts the income eligibility level for exemption from taxation of a percentage of assessed valuation as set forth in the following schedule:
